

# **ATTENTION ALL EXPORTERS**

Electronic E Form facility has been introduced in WeBOC w.e.f 2nd November, 2015. To facilitate exporters in obtaining their electronic E Forms (from Authorised Banks), an intervening period has been allowed during which they can file requisite applications using their secure WeBOC login/password.

Thereafter all exports through WeBOC that take place on or after 11th November 2015, must have Electronic E Form attached to their respective export GD.

So immediately apply to your Bank for Electronic E Form ( though WeBOC system) so that there is no delay in your shipments.

**PUBLIC NOTICE NO. 03/2015-(ESTT-EXPORT), KARACHI**

All the Exporters, Customs House Agents and all other concerned persons, departments as well as organizations are informed that in line with Circular No. 10/2015, dated 26/10/2015 issued by the State Bank of Pakistan and consequent to the detailed deliberations and numerous UATs (User Acceptance Tests) held with stakeholders, the electronic filing of Form-E system is being rolled-out with effect from 02.11.2015 at East Wharves and West Wharves, Karachi.

2. In view of the above, all Export Goods Declarations (GDs) through WeBOC would invariably be submitted and completed only on filing of the electronic E-Form. As a consequence, the present practice of uploading E-Forms in the WeBOC as well as physical submission of E-Forms would be done away with w.e.f the date of operation for the new system.

3. All Exporters and Customs House Agents who do not have an active WeBOC User ID or the ones who are presently filling One-Customs GDs without WeBOC User ID must get their User IDs activated or get registered to receive new User IDs immediately in order to avoid any last-minute hiccups. All Exporters, Custom House Agents and all other concerned persons, departments and organizations are, therefore, advised in their own interest to adhere to the above instructions for seamless exports.

4. Mr. Yawar Nawaz, Deputy Collector (Exports), West Wharves / KICT, Karachi, is appointed as Focal person for coordination and assistance with relevant departments / Users and all other stakeholders. His contact is as follows:


